PURPOSE:

The purpose of this Aging Program Directive is to transmit the final FY 14-15 SCSEP funding allocation levels for the ten AAAs that receive SCSEP funds from the Department.

BACKGROUND:

This Aging Program Directive (APD) replaces only the allocation schedule (Exhibit 1, 4-24-14) in APD #14-05-01 with a revised SCSEP allocation schedule for FY 14-15 (Exhibit 1, Revised 2-6-15). Please note that the SCSEP allocation levels have only changed for the following three AAAs: Lehigh, Lycoming-Clinton, and Erie. For the other seven AAAs, the final SCSEP allocation level is the same as the amount included in APD 14-05-01. **These seven AAAs do not need to take any action regarding this APD.** It should be noted that the Schuylkill County AAA relinquished all of its SCSEP funds to the Department shortly after the issuance of APD #14-05-0. These funds were provided to Experience Works to provide SCSEP services in Schuylkill County. This is the reason that Schuylkill appears on Exhibit 1 in APD# 14-05-01 but does not appear on Exhibit 1 of this APD.

The attached Exhibit 1, Revised 2-6-15, reflects the final FY 14-15 AAA funding allocations for the SCSEP Program. AAAs must ensure that the correct allocations are utilized.

SUBMISSION REQUIREMENTS:

The FY 14-15 SCSEP Grant Amendment is due no later than Friday, March 13, 2015. The FY14-15 amendment package must be transmitted electronically to the Department in accordance with "Procedures for AAAs to Submit Program Reports to the Department." The amendment package must include all of the following documents:

U0115XX.XLS (Budget) – Completed for Period (2)

Refer to APD #14-05-01 for instructions on how to complete the budget. The Department requires the submission of an amended line item budget, which includes the display of the Agency's total projected annual expenditures from all resources.
