**Purpose:** The purpose of this Aging Program Directive (APD) is to transmit the final FY 17-18 SCSEP funding allocation levels for the eight AAAs that received SCSEP funds from the Department in FY 17-18.

**Background:** Previously, the Department issued the FY 17-18 SCSEP funding allocations to the AAAs on August 7, 2017 through APD 17-05-02.

**Directives:** This APD replaces only the allocation schedule (Exhibit 1) in APD 17-05-02 with a revised SCSEP allocation schedule for FY 17-18 (Exhibit 1, revised 2-5-18). Please note that the SCSEP allocation levels have only changed for the Northampton County AAA. For the other seven AAAs, the final FY 17-18 SCSEP allocation level is the same as the amount included in APD 17-05-02. These seven

AAAs do not need to take any action regarding this APD. The attached Exhibit 1, Revised 2-5-18, reflects the final FY 17-18 AAA funding allocations for the SCSEP Program. AAAs must ensure that the correct allocations are utilized.
