## **Clinical: Strengthening Care Coordination**

**CHC Goal:** Strengthen coordination of LTSS and other types of health care including all Medicare and Medicaid services for dual eligible individuals

- Involves and promotes coordinating care between CHC-MCOs and D-SNPs for **nursing facility, acute care, behavioral health**

## **Non-Clinical: Transitioning from Nursing Facility to the Community**

**CHC Goal:** Enhance Community Based Living Opportunities

- Promotes Coordinating care between CHC-MCOs and D-SNPs for **nursing facility and behavioral health**

# Medicaid Only Services

- **7.87%** of individuals enrolled in a Community HealthChoices Managed Care Organization (CHC-MCO) received a Medicaid Only service in 2018
  - **Mental Health Crisis Intervention**
  - **Methadone Maintenance**
  - **Mobile Mental Health**
  - **Peer Support Services**
  - **Targeted Case Management**
- In comparison to Behavioral Health (BH) HealthChoices **6.78%** of individuals enrolled in a Behavioral Health Managed Care Organization (BH-MCO) in a Southwestern County received at least one of these services in 2018
