Discussion Items and Summary

Welcome

Secretary Torres opened the meeting with a welcome to members and attendees and made the following announcements:

- Welcomed Adrienne Peter Sipes and Megan Stedjan as they recently joined the Council.
- Secretary shared his gratitude to Margie Zelenak for advocating on behalf the LTCC by presenting the Blueprint Report at the Long-Term Workforce hearing held by the House Aging and Older Adults Committee. PDA provided copies of the Blueprint to Chairman Day, Minority Chair Samuelson and Representative Shusterman. - LTCC Council member listing is now available via the PDA website.
- The Council members will be receiving a survey following this meeting to assist us in how to best facilitate future meetings.

Approval of Meeting Minutes

A motion to approve the February 10, 2022, minutes was made by Lon Wible and seconded by David Nace, MD. The minutes of the February 10th Council meeting were unanimously approved.

Commonwealth Updates

PA Department of Aging (PDA) - Secretary Torres reported on the following updates:

- **Property Tax Rent Rebate (PTRR)** Discussed Governor's proposal to increase property tax rent rebate amounts this year with a one-time rebate bonus that would double the amount. Welcomes Council's support to pass this bill.
- Advisory Council on Elder Justice of the Supreme Court Administration for Community Living has issued competitive grant opportunity to improve guardianship systems. Consideration is being given to submitting a proposal for Pennsylvania which would be well positioned because of all the work done over past several years on development of guardianship tracking system.

PA Department of Health - Lori Gutierrez, Policy Director and Melissa Myers, Executive Policy Specialist

Provided an overview of the Alzheimer's Disease and Related Disorders <u>website</u> implemented in accordance with Act 9.

- Act 9 became effective on April 10, 2022.
- Joint press release issued by DOH and Aging on April 14, 2022.
- Multiple agencies and stakeholders assisted with providing information for the website.
- Available in different languages.
- Information included is from accredited sources.

PA Department of Human Services (DHS) – Jennifer Hale, Director of the Bureau of Policy and Regulatory Management for DHS' Office of Long-Term Living (OLTL), provided departmental updates as follows:

Updates and Primary Focus of OLTL – Effort to increase the coordination of behavioral health services for CHC participants. Stakeholders expressed interest on what the department is doing to provide access.

- The first webinar was held on April 12th
 - o Approx. 90 attendees participated.
 - Webinars geared towards nursing staff education on how to access behavioral health services.
 - Joint effort between OLTL, Mental Health and Substance Abuse
 Services, the behavioral health managed care organizations and CHC.
 - The webinars were hosted by PA Healthcare Association.
- Additional collaborators include DOH and LeadingAge PA.
- Presentations were provided by OLTL, CHC, and behavioral health MCOs and providers.
- Additional webinars: Tuesday, April 26 and May 3, 2022, from 2:00pm-3:30pm. An announcement will go out and be posted on the website.

ARPA Updates:

- Reviewed funding opportunities specific to home and community-based quality improvement initiatives to help improve these services.
- Information will be announced next week.
- Funding will address housing, health, employment, food insecurities, technology, and training.

Follow up information from the February meeting:

• Question concerning vaccination rates. Vaccination rates data is posted to the website under Covid-19 data. The data reflects time period through September 2021.

- Survey to go out in May for information related to boosters.
- Once the survey information is completed it will be shared with the Council and posted to the website.

Commonwealth Update – Susan Coble, Director, Bureau of Community Program Licensure and certification, PA Department of Health

Faith Haeussler, Director, Office of Intergovernmental Affairs, PA Department of Health

Highlights from 2021 – Nursing Homes and Quality Assurance

- 688 facilities in the last year which represents 87,270 beds.
- 2-3 facilities are closing their doors.
- 4,797 total surveys completed in 2021.
- 618 were recertification surveys through CMS.
- 1,406 revisits
- 3,974 on-site visits, includes complaints and Covid-19 surveys.
- 758 Covid-19 surveys

Complaints 2021:

- 4,185 substantiated 33%. 4,125 were completed.
- Most frequently included quality of care, infection prevention and control, free of accidents and hazards, procurement, storing, preparation and servicing.
- Total number of incidents reported was 45,690
- Hospital transfers were 10,378 and others 5,089.

Faith Haeussler presented on Covid-19 updates

- Covid-19 case counts are down and at the lowest since August 2021 and continuing to decline.
- Opportunity to reflect on how DOH can be best prepared moving forward.
- Cases will continue to rise and fall.
- Variants will continue to change.

- Created 3 E's
 - Evaluate threats
 - Empower individuals
 - o Enable care.
- 3 additional monitoring systems
 - Baseline Preparedness
 - Emerging threat
 - Surge response
- Interested in feedback and speaking with interested parties.

Q: Is there a timeframe in mind for a final product?

A: What is being built now is the framework with teams working from 6-7 different areas.

Q: When will information be available for Council members?

A: Members can reach out to Faith Haeussler, no exact date yet available.
