WITNESSETH:

WHEREAS, the Placement Agency wishes to place an adult, age 18 years or older, who has been determined to be eligible for Domiciliary Care, and

WHEREAS, the home of the Provider has been certified as meeting the requirements for such certification as promulgated in Pennsylvania Code, Title 6, Chapter 21, Domiciliary Care Services for Adults, and

WHEREAS, the Placement Agency has approved the house rules for the provider's home, as set forth in the attached Consumer Provider Agreement, Exhibit A.

Now, therefore, the parties hereto mutually covenant and agree as follows:

- 1. The Placement Agency will be responsible for duties as set forth in Attachment _____.
 - seek out Domiciliary Care eligible adults and place these adults in Domiciliary Care homes suited to their needs;
 - perform continuing periodic contact with adults placed in Domiciliary Care homes to assure adequacy of care and appropriateness of placement;
 - orient and train Domiciliary Care providers;
 - assure provision of services by Domiciliary Care providers in accordance with Domiciliary Care regulations;
 - comply with all other requirements as stipulated in the Domiciliary Care regulations.
- 2. The Provider will:
 - provide the Domiciliary Care consumer with a supportive social environment;
 - provide the Domiciliary Care consumer with a safe physical environment and nutritious diet;
 - assist the Domiciliary Care consumer in developing or maintaining self-help skills within his/her capacity;
 - perform personal care tasks for the Domiciliary Care consumer when he/she cannot;

- comply with all other requirements as set forth in the Domiciliary Care regulations.
- 3. The Placement Agency and the Provider shall comply with all the requirements of Title VI of the Civil Rights Act of 1964 and the Pennsylvania Human Relations Act.
- 4. The Placement Agency shall have, and the Provider shall allow, free and full access to the Domiciliary Care Home and its records that pertain to any aspect of the Domiciliary Care program.
- 5. Any alterations, variations, or modifications of this agreement shall only be valid when they have been reduced to writing, duly signed, and attached to the original of this agreement.
